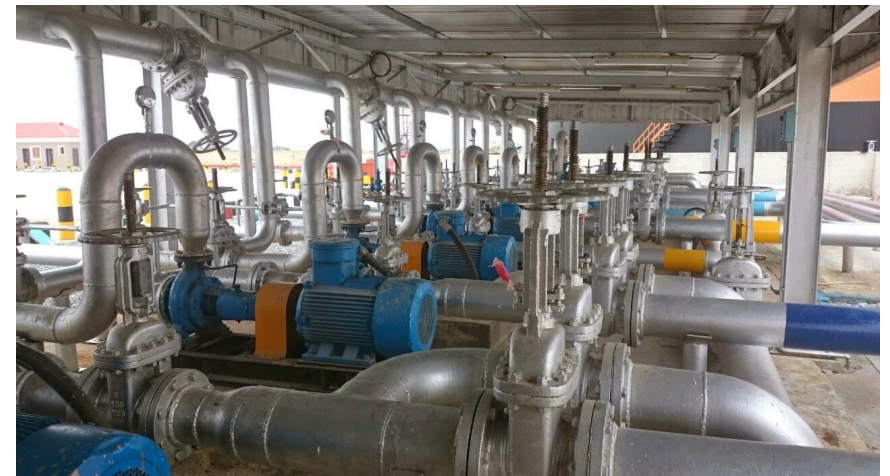


# Group Structure

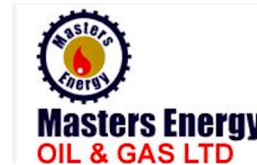
